

This notice will remain force until further notice.





NOTIFICATION

In view of second wave of COVID-19 pandemic Emergency situation and contain of COVID-19 in the district and in exigency of public at large, the following institution declared as Dedicated Covid Care Centres (DCCCs) given in the Tablet-A which will be exclusively used for management of COVID-19 patients.

In pursuance to the Order No-11181 dtd. 12.04.2021 of Additional Chief Secretary to Govt., Govt of Odisha, Health & Family Welfare Dept. the following institution are hereby renamed as **Dedicated Covid Health Centres (DCHC)** instead of Dedicated Covid Care Centre (DCCC).

1. DCHC ST Girls' Hostel & Urban Boys' Hostel, UB High School Bhanjanagar
2. DCHC Leprosy Hospital Babanpur, Aska
3. DCHC SDH Hinjilicut Old Building


