## **Notification for CAS-2025**

In pursuance of Letter No. SDTE-THE-THE-II-0042-2017/6073 dated 13.09.2025 of SD & TE Department, Government of Odisha, all eligible teachers of the College may apply in the prescribed format available in the College website, for his/her promotion from the present Level to next higher Level under Career Advancement Scheme (CAS) by filling the Form Annexure-I (Part-A, Part-B, Part-C, Part-D, Part-E and Part-F) with all supporting documents. The application, through proper channel must reach the Establishment Section on or before 08.10.2025.

### **General Instructions:**

1. Teachers who become eligible for CAS promotion by last date of Notification may apply.
2. The prescribed application form can be downloaded from the College website.
3. The deadline to acquire mandatory requirements as given in Annexure II for CAS promotion was 31st December, 2024.
4. The duly filled-in application form (04 Sets) must be enclosed by self-attested copies of all relevant documents in support of academic qualification, teaching & research experience, all research publications (First page), data/information given in 360° feedback score for all academic years, FDP/MOOCs course, industrial/professional trainings, PhD guided etc. as detailed in the form. The candidate may increase the number of rows/adjust columns/use extra sheets in prescribed format, wherever required.
5. Candidates are required to produce the original degree certificates of educational qualifications starting from UG to Ph.D. and all other relevant original documents for verification at the time of scrutiny/interview.
6. Best Research Publications, as applicable (Annexure II), in the form of hard copy.
7. Copy of Appointment/Promotion order at present position.
8. The incumbent faculty needs to authenticate each page of the application form and enclosures by his/her full signature on each page indicating their Page Number at bottom right hand corner on all pages of the document.

9. Any other documents in support of data/information given in the application.
10. 360° degree feedback for two academic session for 2019-20 and 2020-21 is exempted as per AICTE Corrigendum No F. No.27/T & LB/Pay/01/2022-23/58(Dec.) dated 11.07.2023.
11. Applications received in incomplete form or not in prescribed format shall be rejected.
12. The incumbent faculty members are required to appear before the Screening-cum-Evaluation Committee (SEC) for scrutiny of their application forms and evaluation of feedback score etc. The faculty members recommended by the SEC will then be evaluated by the Selection Committee (SC) through an interview process. The candidate has to secure a minimum of 50 marks out of 100 in the interview to qualify for promotion. Failure to appear before the SEC and SC at the scheduled date and time, for any reason whatsoever, will result in forfeiture of all claims to promotion.

**Note:** It is also made clear that the candidature of the candidates for the promotion is purely provisional. The candidature is liable for rejection in the event of inadequacy/deficiency found at any stage during or after the selection.
