PROCEDURE FOR SUBMISSION OF BID:

The participating Bidders should submit a Bid in Three (03) Separate Sealed Envelopes.

i) Technical Bid (Envelope A)

The bidders should submit the Following Documents along with the Technical Bid, I .e. Envelope A:

- a) PAN, GST Registration Certificate and Bank Account Details.
- b) Past two years Work Order / Purchase Orders /Testimonials /Performance Certificate pertaining to the supply and installation of fan or any other electrical equipment.

This envelope should be SUPERSCRIBED with the following text: "***Technical Bid for Supply, Installation, Testing and Commissioning of Tamper-Proof Rods of Ceiling Fans at PMEC Berhampur Hostels***".

ii) Price Bid (Envelope B)

Price bid must be quoted as per the format specified, failing which the bid will be rejected. The Price Bid should be put in a separate cover, and the cover should be in a sealed condition. This envelope should be SUPERSCRIBED with the following text: "***Price/Financial Bid for Supply, Installation, Testing and Commissioning of Tamper-Proof Rods of Ceiling Fans at PMEC Berhampur Hostels***".

iii) Master Envelope (Envelope C)

Contains both Envelope A and Envelope B. This envelope should be SUPERSCRIBED with the following text: "***Tender for Supply, Installation, Testing and Commissioning of Tamper-Proof Rods of Ceiling Fans at PMEC Berhampur Hostels***".

II.EVALUATION PROCESS:

The process for selection of the successful Bidder would be determined as under:-

Stage 1: Evaluation of Technical Bid: The bidders who submitted all required documents as per the technical requirements of the tender will be eligible to further evaluation process. The Bidders' Competency will be assessed by the previous experience documents submitted in the Technical Bid.

The decision taken by the Institute will be final and binding.

Stage 2:Opening of Financial Bid: The price bids of all the eligible bidders (from Stage I) will be opened in the presence of the committee members and bidders or authorized representatives. The lowest price quoted by the Bidder in the Price Bid will be considered a successful Bidder (L1), and the Purchase/Work Order/Letter of Award will be awarded to the L1 Bidder.

III. Other Terms & Conditions:

- a) The bid forwarding letter (Annexure-II & II) is a part of the Technical bid.
- b) The bidder should submit the Tender duly signed and stamped on all the pages
- c) The financial bid shall be open only technically qualified bidder in the presence of the intending bidders or their authorized representatives, if they wish to be present at that time.
- d) The tender job will be awarded on L1 basis, not on an individual item basis. L1 will be decided on the basis of the total quoted rates of all items, such as supply, transportation, labour cost, GST,etc., of technically qualified bidders only.
- e) Purchase preference shall be applicable for MSEs as per guidelines issued by Department of MSME, Govt of Odisha.
- f) The successful bidder should supply and install the item as per the technical specifications.
- g) The agency should install the tamper proof ceiling rod of length 12 inches or of suitable length to match the order and aesthetics. During installation hooks/fasteners, if required will be changed within the quoted price.
- h) It is the responsibility of the successful bidder to supply and install all items in good condition. If any item is found damaged/broken in transit, the Vendor should replace them within fifteen days, and the payment will be released to the vendor only after completing the same.
- i) After the selection of the successful bidder, a Work Order shall be issued by the Institute to the Successful Bidder, and the Successful Bidder shall within 05 (five) working days of the receipt of the WO, sign and return the duplicate copy of the WO in acknowledgement thereof.
- j) The Institute reserves the right to modify the conditions of the tender at any time without assigning any reasons for the same.
- k) PMEC Berhampur reserves the right to accept/reject any bid without assigning any reason whatsoever.
- l) If the last date of opening of the bid coincides with a holiday, then the next working day shall be the opening.
- m) The Supply, Installation, Testing and Commissioning should be completed within **one month** of the confirmed work order, or else an amount equivalent to 1% of the total value per week of delay will be deducted from the payment to the bidder or as decided by the Competent Authority.
- n) PMEC Berhampur will seek clarification from the bidder for the evaluation of bids, and the decision made by PMEC Berhampur will be final.
- o) No financial information should be disclosed in the technical bid. Otherwise the bid shall be rejected.
- p) All disputes arising out of this contract shall be subject to the Courts at Berhampur.
